On Interstate 8 (I-8) in La Mesa and El Cajon, County of San Diego from 0.1 mile west of Severin Drive overcrossing to 0.1 mile east of West Main Street undercrossing. The project proposes to rehabilitate the bridge deck and construct new bridge rails. The project proposes to remove 1.5-inches of the existing bridge deck overlay and replace it with 1-inch of polyester concrete overlay and 4.5-inches of structural concrete. An overhead sign will be removed and replaced, new bridge rails, new concrete barrier and terminal systems, approach and departure slabs, and concrete tapers will be constructed.
