

**Reasons Why Project is Exempt:** Section 15301, *Existing Facilities*, consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The proposed park improvements does not result in expansion of use it only involves the rehabilitation of existing facilities within the park site. The park will not be expanded. Thus, the proposed project is exempt from further environmental review.
