SUBJECT: WORK PLAN FOR PHASE II ENVIRONMENTAL SITE ASSESSMENT APN 0163-362-26-0000  
(GRIFFIN PARCEL) NEAR MAIN GUYAUX WASTE DISPOSAL SITE (SWIS NO. 36-CR-0025)

Dear Mr. Hansen:

On June 6, 2019, the Local Enforcement Agency (LEA) of San Bernardino received the Work Plan for Phase II Environmental Site Assessment for APN 0163-362-26-0000 (Griffin Parcel) near Guyaux Waste Disposal Site, Terminus of South Florez and Fernando Streets, Colton, California 92324 (SWIS No. 36-CR-0025). The plan proposed an assessment to evaluate whether possible buried wastes may be present in two specific areas of Griffin Parcel. These specific areas include:

- 1) a former disturbed area adjoining the west southwest edge of the Site, and;
- 2) the northern-most one acre of the Site which is adjoining to the west and southwest of the main Guyaux Waste Disposal Site.

San Bernardino County LEA and CalRecycle have reviewed the proposed work plan. With guidance from CalRecycle, the LEA has determined that Guyaux Waste Disposal Site may proceed with the proposed plan with the following provisions:

- If during the intrusive investigation it is determined that there has been waste deposited that has the potential to produce gas, then landfill gas probes should be constructed at the property boundary adjacent to the homes.
- Information/review of historical aerials for APN 0163-362-26 (Griffin Parcel) which will include an EDR historical aerial package (1930-present).
- Trench logs will include the depth of waste (to native), cover thickness, and description of waste (if found).
