

The following environmental resource has been identified at Relinquishment Parcel 88114:

Segment 1 is underlain by a high potential paleontological resource. High potential includes rock units which, based on previous studies, contain or are likely to contain significant vertebrate, significant invertebrate, or significant plant fossils. These units include, but are not limited to, sedimentary formations that contain significant nonrenewable paleontological resources anywhere within their geographical extent, and sedimentary rock units temporally or lithologically suitable for the preservation of fossils. Excavation or grading activities on Segment 1 could discover scientifically significant fossils.
