Caltrans proposes to remove and replace 0.25 feet of existing hot mix asphalt and cap with 0.10 feet of Rubberized Hot Mix Asphalt BWC Type G on State Route 41 in both the northbound and southbound directions. The proposed project would include shoulder backing. All work would remain within the existing right-of-way.
