Description of Nature, Purpose, and Beneficiaries of Project:

The City of Downey proposes to construct a series of raised medians as safety enhancements and to improve traffic flow and circulation along Paramount Boulevard, a major arterial road, between Leeds Street and Firestone Boulevard. The project consists of removing existing striped median/pavement, installing raised concrete median island with landscaping and irrigation, left-turn lanes, signage/stripping, repair of miscellaneous concrete surfaces, AC pavement grinding and the construction of rubberized asphalt concrete overlay on lanes adjacent to the new median islands constructed. Once these improvements are completed, traffic throughput and safety along Paramount Boulevard will greatly improve.
