Caltrans proposes to replace ceiling tiles and remove ducting at the Coronado Toll Plaza Maintenance Station. Staff from the Coronado Bay Bridge Crew reported falling ceiling tiles inside the facility. The existing ducting above the tiles is completely concealed from view in interior common areas and will be removed in its entirety. There will be no replacements of hardware visible from interior spaces. All work will be done inside the building. Please see the attached Environmental Commitments Record for a list of commitments. 
