The California Department of Transportation proposes to overlay State Route 155 in Kern County near Glennville from 2.4 miles north of Sandy Creek Fire Road to 0.12 mile south of Adams Road. The overlay will be 0.20' HMA (Type A) and will include 2 feet of shoulder backing on both sides. In addition, damaged areas of the pavement will be repaired by removing and replacing the existing pavement (dig-outs). The purpose of this project is to rehabilitate the roadway and is needed because the existing pavement is deteriorating. No additional right-of-way is required.


