**SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108**

Project Title: Streambed Alteration Agreement No. 1600-2019-0225-R2 "Manoli" Timber Harvesting Plan 2-18-0189-NEV, Sierra Pacific Industries

Project Location: The project is located along an unnamed intermittent tributary in the East Fork Creek Watershed, in Nevada County. Township 19N, Range 12E, Sections 16 of U.S. Geological Survey (USGS) Quad Map Sierra City, Mount Diablo Base and Meridian.

Project: This rock ford is adjacent to a water drafting site and will be repaired by reducing the slope of the eroding bank and adding rock through the crossing extending out 25 feet onto the road on both sides of the crossing. The rock will be 1.5-inch rock (minimum) placed at a 3-inch depth for the crossing. All work will be completed when the area is dry. If water is present in the crossing at the time of the repair, water may be diverted around the work site to ensure a dry work site.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
