Project Description (Proposed actions, location, and/or consequences).

This project will remove the compromised concrete Antone Dam (approx. 60' long, 2' wide, and 4' tall) from across Burton Creek at Burton Creek State Park to restore geomorphic function and form to the meadow and channel; construct a step pool boulder structure to recreate the natural valley grade break and control water at existing levels (to ensure the meadow upstream is neither saturated or drowned); reconstruct the floodplain and channel and revegetate with native vegetation; and construct (and restore) temporary short roads and staging area to access both sides of the project area.

Based on the Initial Study and supporting environmental analysis, the proposed project will result in less than significant impacts for: aesthetics, air quality, biological resources, geology and soils, greenhouse gas emissions, hazards and hazardous materials, hydrology and water quality, noise, transportation, and utilities and service systems. The project would have no impact on: agricultural and forest resources, cultural, tribal cultural resources, energy, land use and planning, mineral resources, population and housing, public services, recreation, and wildfire.
