Specifically the 2045 MTP/SCS is intended to implement regional goals regarding future mobility needs and identify programs, actions and a plan of projects intended to address these needs consistent with adopted goals and policies. The 2045 MTP/SCS includes the Sustainable Communities Strategy (SCS) pursuant to the requirements of SB 375. Accordingly, the 2045 MTP/SCS identifies transportation improvement projects and a land use scenario that would effectively meet SB 375 greenhouse gas emission requirements.


