
Resolution **R5-2020-0037** (Resolution) was adopted by the Central Valley Regional Water Quality Control Board on **4 June 2020** for the Lehigh Southwest Cement Company and Calaveras Cement Company (Discharger). The Resolution adopts Mitigated Negative Declaration and approves Mitigation Monitoring and Reporting Program for CKD-3 Closure project at the Calaveras Cement Plant near San Andreas in Calaveras County.
