PROJECT LOCATION: The Project is located west of Marks Avenue and between Mountain View Avenue to the north and Caruthers Avenue to the south in the City of Caruthers, Fresno County.

PROJECT DESCRIPTION: The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Drinking Water State Revolving Fund (SRF) Program is financing the Project. The Project includes a planning study for a granular activated carbon treatment plant for the Caruthers Community Services District's Well 3 site. The study for the proposed granular activated carbon treatment plant will include project evaluation and pre-design, survey and geotechnical investigation, and environmental review.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: The State Water Board has approved SRF financing for the Project described above on May 10, 2022, and determined that the Project is exempt from the California Environmental Quality Act. The Caruthers Community Services District will be carrying out the Project.
