Project Description: UC Davis will remove and demolish three (3) 10,000 gallon underground fuel storage tanks (UST) located at 2800 49th Street on the UC Davis Sacramento Campus, which is the same site for the Parking Structure 6 (PS6) project. The fuel tanks previously stored diesel and gasoline in support of UC Davis Health’s Fleet Services operations. Fleet Services has been relocated to an off campus, leased facility. In Summer 2022, the fuel pumps associated with the fuel tanks were removed. The Project demolishes remaining fuel lines and the tanks. The excavated areas will be back-filled and made ready for construction of the PS6 project.

This Notice of Determination is to advise that the University of California Lead Agency has approved the above-described project on *October 27th, 2023* and has made the following determinations:

1. The Project would not cause any significant environmental impacts nor an increase in the severity of significant impacts previously studied in the UC Davis Sacramento Campus 2020 Long Range Development Plan Update Supplemental Environmental Impact Report (2020 LRDP Update SEIR).
2. Mitigation measures from the UC Davis Sacramento Campus 2020 LRDP Update EIR were made a condition of the approval of the project; no new project-specific mitigation measures are required.
3. The implementation of applicable UC Davis Sacramento Campus 2020 LRDP Update EIR mitigation measures will be monitored and reported pursuant to the 2020 LRDP Update Final EIR’s MMRP.
4. The previous statement of overriding considerations in the UC Davis Sacramento Campus 2020 LRDP Update EIR was reaffirmed for this project.
5. Findings were made pursuant to the provisions of CEQA.
