Project Title: 48X Construction Trailer Relocation

Project Applicant: University of California, Davis

Project Location: UC Davis Sacramento Campus, 49th Street and 50th Street, Sacramento

Project Description: This project proposes to relocate the existing temporary construction trailers at the 48X Complex Project construction site to a new location on the Sacramento Campus. The trailers are currently located adjacent to the 49th Street and V Street intersection to provide office and support space for the construction of the 48X Complex Project. The trailers are approximately 12,000 square feet in area. The trailers will be relocated to an existing temporary parking area on the Sacramento Campus, on the west side of the MIND West Building adjacent to the 50th Street and 49th Street intersection. The area is currently a gravel parking lot.

This Notice of Determination is to advise that the University of California Lead Agency has approved the above-described project on May 22nd, 2024 and has made the following determinations:

1. UC Davis Sacramento Campus 2020 Long Range Development Plan Update Supplemental Environmental Impact Report (2020 LRDP Update SEIR) sufficiently analyzes and addresses potential environmental impacts from the project, and the project will not trigger any of the criteria requiring additional CEQA review pursuant to CEQA Guidelines Section 15162.
2. The project will not result in new significant impacts or a substantial increase in the severity of the environmental impacts identified in the 2020 LRDP Update SEIR.
3. Mitigation measures from the 2020 LRDP Update SEIR were made a condition of the approval of the project; no new project-specific mitigation measures are required.
4. The implementation of applicable 2020 LRDP Update SEIR mitigation measures will be monitored and reported pursuant to the 2020 LRDP Update SEIR MMRP.
5. The previous statement of overriding considerations in the 2020 LRDP Update SEIR was reaffirmed for this project.
6. Findings were made pursuant to the provisions of CEQA.
