**PROJECT LOCATION:** Arleta Avenue, Irving Avenue, Brooklyn Avenue, Leland Avenue, Scott Street, Boston Avenue, Bailey Avenue, Cleveland Avenue, Laswell Avenue, Richmond Avenue, Rutland Avenue, Vaughn Avenue, Bascom Avenue, Wabash Avenue, and Leigh Avenue, located within Santa Clara County

**PROJECT DESCRIPTION:** The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Clean Water State Revolving Fund (SRF) Program is financing the Project. The Project will rehabilitate existing sanitary sewer mains located within the Burbank Sanitary District. The work will include 38 segments of cured-in-place pipe lining (CIPP) of which there are 11 segments located in the residential home backyards, for a total of 13,634 feet of CIPP. In locations within CIPP area, opening in the laterals will be performed by robotically cutting the lateral openings. The Project also includes 121 spot repairs on ten streets. In spot repair areas, laterals will be reconnected to the new sewer main with the installation of a new wye connection.

**PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:** The State Water Board has approved SRF financing for the Project described above on April 28, 2021 and determined that the Project is exempt from the California Environmental Quality Act. The Burbank Sanitary District will be carrying out the Project.

**CATEGORICAL EXEMPTION STATUS:**

**Class 2: Replacement or Reconstruction**

(California Code of Regulations, title 14, division 6, chapter 3, article 19, section 15302)

**REASON WHY PROJECT IS EXEMPT:** The Project has been determined to meet the requirements of the exemption selected above and will not have a significant impact on

water quality. The Project involves repairing or rehabilitating existing sewer mains within the Burbank Sanitary District. It can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment.
