DOCUMENT TITLE: Linda Manor Community Septic Conversion Project (Project)

PROJECT LOCATION: The Project is located along county right-of-way along Elkhorn Boulevard, West 2nd Street, Chisum Avenue, Willis Avenue, and Magdalena Street in the Linda Manor residential subdivision southwest of the community of Rio Linda in the unincorporated Sacramento County.

PROJECT DESCRIPTION: The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Clean Water State Revolving Fund (SRF) Program is financing the Project. The Project will abandon failing private septic systems and connect 57 single family residences to public sewer facilities. The Project includes approximately 4,800 feet of new 8-inch gravity sewer collector to be constructed within county right-of-way along Elkhorn Boulevard, West 2nd Street, Chisum Avenue, Willis Avenue, and Magdalena Street.

PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT: The State Water Board has approved SRF financing for the Project described above on August 9, 2022. The Sacramento Area Sewer District will be carrying out the Project. The State Water Board has made the following California Environmental Quality Act (CEQA) determinations regarding the Project:

1. The Project will not have a significant effect on the environment. The Project will not have a significant effect on water quality impacts. This determination is limited to effects on water quality under the State Water Board's jurisdiction as a Responsible Agency.
2. A Mitigated Negative Declaration was prepared and adopted for the Project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of approval of the Project.
4. A mitigation monitoring and reporting plan/program was adopted for the Project.
