Project Description: State law requires cities to update their General Plan Housing Element for the 6th Cycle planning period (2021-2029) pursuant to Government Code Sections 65580 through 65589.11. The City of Santa Ana has prepared a Housing Element which includes an analyses required by state law related to: 1) establishment of goals and policies to address housing needs; 2) existing demographics and housing characteristics; 3) market, government, and environmental constraints; 4) resources available to meet housing demand; 5) a review of past accomplishments under the 2013-2021 Housing Element; and 6) an assessment of fair housing issues and contributing factors.

On July 19, 2022, the City Council of the City of Santa Ana (Lead Agency) has:

- Adopted a resolution approving an addendum to the Program Environmental Impact Report for the General Plan Update (State Clearinghouse No. 2020029087); and
- Adopted a resolution approving General Plan Amendment (GPA) No. 2021-01 for the 6th Cycle Housing Element Update subject to conforming edits by the Executive Director of the Planning and Building Agency and the City Attorney to comply with State housing law and mandates.
