Project Description, continued:

The project would construct new water infrastructure (wells, reservoirs, pump station, etc.), integration of the five listed systems and replace aging infrastructure that currently exists.

The water companies joining the new Weldon Regional Water District would include Long Canyon Water Company, Tradewinds Water Association, Bella Vista Mutual Water Company, Lake Isabella KOA, and Rainbird Valley Mutual Water Company. The project requires the development of two new wells, two 0.75 MG reservoirs, 35,000 feet of new 8-12" water transmission pipelines, a new booster pump station, as well as new meters, hydrants, and valves to replace broken, corroding, and non-working infrastructure.
