Project Location (County of Riverside): The project includes project components at fifteen separate streams along State Route 79, east of the City of Temecula and west of the unincorporated community of Aguanga, in the County of Riverside, State of California. The westernmost location is at Kolb Creek Latitude 33.46873°, Longitude -117.00698° and the easternmost location is at an Unnamed Tributary to Temecula Creek, Latitude 33.46402°, Longitude -116.91515°.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number EPIMS-RIV-23941-R6, pursuant to section 1602 of the Fish and Game Code to the project Applicant, California Department of Transportation District 8. The Project will impact 3.32 acres of Fish and Game Code section 1602 resources. The Project will construct install new rock slope protection, construct bridge drainage structures, and replace reinforced concrete box culverts and headwalls.

This is to advise that CDFW, acting as a Responsible Agency, approved the project described above on April 4, 2023 and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
