SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108

Project Title: Streambed Alteration Agreement No. 1600-2018-0300-R2 ("Hen House" Timber Harvest Plan (THP) 2-19-00006-SIE).

Project Location: The projects are located within the Little Wolf Creek and Middle Fork Kanaka Creek watersheds in Sierra County, State of California. The projects are located on the Downieville, Sierra City, Alleghany, and Graniteville U.S. Geological Survey (USGS) Quad Maps, Township 19N, Range 10-11W, Sections 13, 19, 21, 25, 29, 30, 31, Mount Diablo Base and Meridian.

Project Description: The projects include the replacement of one undersized culvert (map point 31-4), maintenance of three existing class II rocked ford road crossings (map points 21-2, 21-10, 21-17), and the repair of two ditches adjacent to existing culverts (map points 19-5, 29-2). Further explanation of this work can be referenced in section 26d of the THP 2-19-00006-SIE.

This is to advise that CDFW, acting as a Responsible Agency, approved the above described project on the date signed below and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
