

Notice of Intent to Adopt a Mitigated Negative Declaration Study Results Available Public hearing scheduled for changes to U.S. 395



What's Being Planned: The California Department of Transportation (CALTRANS) is considering the "Meadow Farms ADA Project", which proposes to widen highway shoulders and build sidewalks which meet current Americans with Disabilities Act (ADA) standards from postmile 117.3 to 117.9 on U.S. 395 near the City of Bishop.

Why This Ad: CALTRANS has studied the effects this Project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called a Recirculated Mitigated Negative Declaration (MND) and Initial Study/Environmental Assessment. This notice is to tell you of the preparation of the recirculated report, its availability for you to read and offer comments, and to notify you that there will be a public meeting.

Three Project alternatives were previously released for public comment in April 2020. This Notice refers to two additional Project alternatives which were developed after considering initial public comments. All five Project alternatives are now under consideration.

Public Meeting Scheduled: Due to quarantine restrictions from COVID-19 an in-person meeting is not possible at this time. **An online public meeting will be held Wednesday, November 4th 2020 from 6-7:30 pm.** This meeting will include a brief overview of the new Project alternatives as well as an opportunity to ask questions about the Project.
