On April 27, 2020, Midpeninsula Regional Open Space District (Midpen) released a Notice of Preparation (NOP) for the proposed [Wildland Fire Resiliency Program](#), starting a 30-day comment period (SCH 2020049059) that was scheduled from April 27 through May 28, 2020. Per the NOP, written comments could be submitted via email or postal mail to Midpen. Staff also developed an online comment form as an additional method for comment.

On May 11, 2020, staff learned that one of two links to the comment form did not work. During the May 13<sup>th</sup> Scoping meeting with Midpen's Board of Directors, a request for a time extension was also expressed. Midpen is therefore extending the comment period to Thursday June 18, 2020 at 5:00 pm.
