The proposed Project consists of two elements. The first part of the Project is a General Plan Amendment and Development Code Amendment ("Amendments") to permit off-site advertising Electronic Messaging Centers (EMCs) within the City of Yucaipa. The Amendments would permit up to three (3) different EMCs within the City, adjacent the Interstate 10 corridor that passes through the City of Yucaipa. The second part of the Project are three (3) Conditional Use Permit and Development Agreement ("Use Permits") to construct EMCs consistent with the provisions of the Amendments.
