Project Location (include county): The Project is located at the North Fork Mokelumne River (North Fork) and the South Fork Mokelumne River (South Fork), on State Route State Route 26 in the County of Amador and the County of Calaveras, State of California. The post miles (PM) for this Project are CAL-26 PM 29.9 -30.1, CAL-26 PM 38.2 - 38.3, and AMA-26 PM 26.0 - 26.1.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement EPIMS Notification Number CAL-22613-R2, pursuant to section 1602 of the Fish and Game Code to the Project Applicant, California Department of Transportation.
