



BEWLEY STREET TOWNHOMES PROJECT NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Subject: Notice of Intent (NOI) to Adopt a Mitigated Negative Declaration for the Bewley Street Townhomes Project

A Mitigated Negative Declaration (MND) has been prepared by the City of Santa Ana for the Bewley Street Townhomes Project located at 1122 North Bewley Street. Pursuant to the California Environmental Quality Act (CEQA), the City of Santa Ana, as Lead Agency, is responsible for preparation of this document.

PROJECT TITLE: Bewley Street Townhomes Project

PROJECT DESCRIPTION: The project proposes to develop a ten-unit townhome community distributed among four separate two-story buildings, each with two to three units. The units would range in size from 1,618 to 1,950 square feet, each consisting of two to four bedrooms and a 400-square foot attached two-car garage. The project would require the discretionary approvals of a General Plan Amendment and a Tentative Tract Map.

The project site is not listed on any hazardous materials or waste databases pursuant to Section 65962.5 of the Government Code.

PROJECT LOCATION: 1122 North Bewley Street, Santa Ana, California 92703

PUBLIC REVIEW PERIOD: The 30-day public comment period on the MND will commence on Wednesday, May 6, 2020, and conclude on Thursday, June 4, 2020. Due to Governor Gavin Newsom's Executive Order and the Santa Ana City Council's Proclamation of Local Emergency related to the COVID-19 pandemic, all City facilities, including City Hall and libraries, have been closed until further notice. 
All comments received will be included in the final package that is forwarded to the Santa Ana City Council for final consideration.

A public hearing of the Santa Ana City Council to consider approval of the project and adoption of the MND will be held at the City of Santa Ana Council Chambers, located at 22 Civic Center Plaza, Santa Ana, CA 92704, scheduled on Tuesday, July 7, 2020 at 5:45 p.m. All evidence and testimony for or against the approval of the project and adoption of the MND will be considered. All persons desiring to comment on the content or adequacy of the MND may be heard before the City Council.

Due to the COVID-19 pandemic, the City can no longer offer an in-person meeting location for the community to attend public hearings. As such, viewing the scheduled Planning Commission and City Council hearings on the proposed project will be offered remotely via cable television, YouTube, or live stream.
