Project Description: The property located at 533 River Run, Clio, is zoned S-1 (Suburban), which permits residential uses. The property owners plan to use the property and existing steel building "as a secure place to store vehicles, equipment, and supplies for a yard maintenance business."


The General Plan Amendment and Zone Change will change the Suburban designation and S-1 (Suburban) zoning to the Commercial designation with C-2 (Periphery Commercial) zoning; retaining Scenic Road designation and SP-ScR (Special Plan Scenic Road) zoning and the F (Farm Animal Combining) zoning.


