
Would you like a hard copy or an electronic copy of the Initial Study written for the proposed bearing pad replacement for Little Potato Slough Bridge in San Joaquin County?

#### PUBLIC COMMENT PERIOD

Comments will be accepted from May 18, 2020 to June 17, 2020.

#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to replace failed elastomeric bearing pads and joint seal assemblies at the Little Potato Slough Bridge (bridge number 29-0101), located just west of Lodi, California, within San Joaquin County. Caltrans also proposes to remove a portion of structural concrete and provide an access opening in the soffit and install temporary falsework on a pile foundation to temporarily support the bridge structure during the replacement of the bearing pads and joint seal assemblies.



#### WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. This notice is to tell you of the availability of the Initial Study with Proposed Mitigated Negative Declaration, which you can now read and comment on.
