**NOTICE OF INTENT TO ADOPT A
MITIGATED NEGATIVE DECLARATION**

Notice is hereby given that the County of Fresno has prepared Initial Study (IS) No. 7334 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY NO. 7334 filed by **FRESNO COUNTY DEPARTMENT OF PUBLIC WORKS AND PLANNING, DESIGN DIVISION**, proposing to replace the functionally obsolete Fresno Canal Bridge on N. Del Rey Avenue. The existing 2-lane timber bridge would be replaced with a new 2-lane concrete bridge that meets current standards. The Fresno Canal Bridge is located on N. Del Rey Avenue, 0.5 miles south of its intersection with East McKinley Avenue. Adopt the Mitigated Negative Declaration prepared for Initial Study No. 7334.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Mitigated Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS No. 7334 and the draft Mitigated Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.

Public Comment Period

The County of Fresno will receive written comments on the Proposed Project and Mitigated Negative Declaration from March 12, 2021 through April 12, 2021.
