Project Description:	To allow for the recordation and development of a 74-lot single family residential subdivision (Tentative Tract Map 20280) with 7,200 sq. ft. minimum size lots, on an approximately 20.6 acre building site that is vacant and undeveloped with an approximate density of 3.6 units per acre.
