DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT:

This project will make improvements to Ann Skager Trail to ensure park visitors remain on the designated trail, including an approximately 37-foot section of wood split-rail fence along an end curve section of the trail, a chain link gate will be installed about 30 feet west across the volunteer trail at an old fenceline, and the removal and re-positioning of trail edging.
