Project Title: Tule Subbasin Advisory Committee/Tule Basin Water Quality Coalition (TBWQC) Monitoring Wells TSMW-6L and TSMW-6SM

Project Location - Specific: The project is located approximately 1,250 feet west of Road 224 and 500 feet south of Avenue 24, approximately 2.5 miles northeast of Richgrove, Tulare County, within County APN 339-120-019.

Project Location- Section, Township, Range: Section 20, Township 24 S, Range 27 E of the Richgrove USGS 7 1/2 minute quadrangle

Project Location - City: Northwest of the Community of Richgrove Project Location - County: Tulare

Description of Nature, Purpose, and Beneficiaries of Project: This project includes the installation of two groundwater monitoring wells within the Tule Subbasin consistent with the Sustainable Groundwater Management Act (SGMA). The wells have been designed and will be located in an area considered "data-gap" based on existing wells and monitoring data. The wells will be located approximately 100 feet from each other. Well TSMW-6L will be drilled to a depth of 610 feet and Well TSMW-6SM will be drilled to a depth of 2,000 feet.





The project site is located on previously disturbed agricultural land and no other construction-related activities are proposed with the project. As such, Section 15303 is applicable and appropriate for this project.
