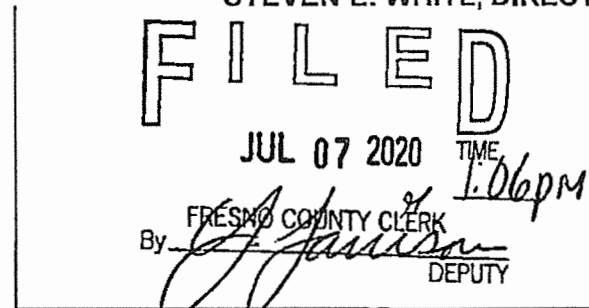

**NOTICE OF INTENT TO ADOPT A
NEGATIVE DECLARATION**

Notice is hereby given that the County of Fresno has prepared Initial Study Application (IS) No. 7308 pursuant to the requirements of the California Environmental Quality Act for the following proposed project:

INITIAL STUDY APPLICATION NO. 7308 and **VARIANCE APPLICATION NO. 4026** filed by **GARY ROBERTS**, proposing to allow the creation of a 2.5-acre parcel (Parcel A) and a 17.05-acre parcel (Parcel B) from an existing 19.55-acre parcel in the AE-20 Zone District (Exclusive Agricultural, 20-acre minimum parcel size) where 20 acres is the minimum parcel size. The subject parcel is located on the east side of Thompson Avenue, between Jensen and North Avenues, approximately 1.7 miles west of the City of Sanger. Address: 2374 S. Thompson Avenue, Sanger, CA. APN: 332-021-22 Sup. Dist. 4. Adopt the Negative Declaration prepared for Initial Study Application No. 7308 and take action on Variance No. 4026 with Findings and Conditions.

(hereafter, the "Proposed Project")

The County of Fresno has determined that it is appropriate to adopt a Negative Declaration for the Proposed Project. The purpose of this Notice is to (1) provide notice of the availability of IS Application No. 7308 and the draft Negative Declaration and request written comments thereon; and (2) provide notice of the public hearing regarding the Proposed Project.

The County of Fresno will receive written comments on the Proposed Project and Negative Declaration from July 8, 2020 to August 7, 2020.
