Subject: State Route 1 and State Route 84 Structure and Scour Mitigation Project – Notice of Availability of Draft Initial Study with Proposed Mitigated Negative Declaration (IS MND), Notice of Virtual Public Meeting

The California Department of Transportation (Caltrans) has prepared a Draft Initial Study with Proposed Mitigated Negative Declaration (IS MND) for the State Route (SR) 1 and SR 84 Structure and Scour Mitigation Project. Caltrans is the lead agency under the California Environmental Quality Act (CEQA). The project proposes to protect the Pilarcitos Creek Bridges on SR 1 in the City of Half Moon Bay, and the San Gregorio Bridge on SR 84 near the unincorporated community of La Honda, both in San Mateo County, California. Caltrans is proposing scour protection at the bridges by placing partially grouted rock slope protection around the bridge piers and abutments. At the SR 1 location, the existing public trail along the north bank of Pilarcitos Creek will be removed during construction and replaced in kind at project completion.

We welcome your input. To protect the public's health and safety, due to the COVID-19 emergency, a virtual open house will be held. You are invited to participate on Tuesday, July 28, 2020, from 6:00 pm to 7:30 pm.
