NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION MONTEREY COUNTY PLANNING COMMISSION

NOTICE IS HEREBY GIVEN that Monterey County Resource Management Agency – Planning has prepared a draft Mitigated Negative Declaration, pursuant to the requirements of CEQA, for a Combined Development Permit (Steppe Stephen M & Sara R Trs, File Number PLN180537) at 2497 San Antonio Avenue, Carmel-By-The-Sea (APN 009-412-004-000) (see description below).

The Mitigated Negative Declaration and Initial Study, as well as referenced documents, are available for review at Monterey County Resource Management Agency – Planning, 1441 Schilling Place South 2nd Floor, Salinas, California,. The Planning Commission will consider this proposal on **September 30, 2020**. Written comments on this Mitigated Negative Declaration will be accepted from July 23, 2020 to August 24, 2020.

Project Description: Demolition of an existing 449 sf garage and construction of an 1,165 sf addition (approximately 689 sf to the main level and 475 sf to the basement) to an existing 1,414 sf single family dwelling and basement, resulting in a 2,577 sf one-story structure, including an attached garage and the basement addition, within 750 feet of known archaeological resources.

We welcome your comments during the 30-day public review period. You may submit your comments in hard copy to the name and address above.
