

## PUBLIC NOTICE

### Notice of Availability of Draft Initial Study with Proposed Mitigated Negative Declaration/Environmental Assessment (IS/EA) and Notice of Virtual Open House for the U.S. Highway 101 Cordilleras Creek Bridge Replacement Project.

**WHAT'S BEING PLANNED:** The California Department of Transportation (Caltrans) proposes to replace the existing Cordilleras Creek Bridge on United States Highway 101 in the City of Redwood City in San Mateo County at Post Mile 7.13. The existing bridge is at the end of its service life and in need of replacement. The project will be constructed in six stages in order to maintain 6 general-purpose traffic lanes in each direction on U.S. 101 during construction activities.

In accordance with the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA), Caltrans has prepared a Draft IS/EA for the proposed project. The Draft IS/EA describes and evaluates the potential environmental impacts associated with the proposed project.

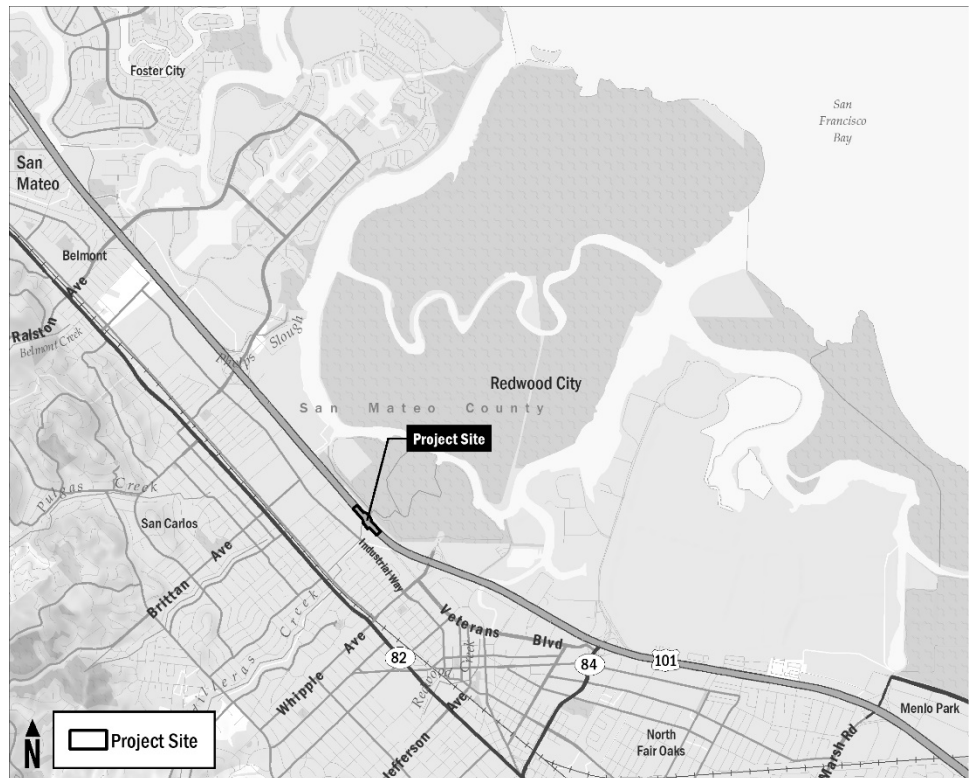
The project is exempt per 40 Code of Federal Regulations (CFR) 93.126, and an air quality conformity determination

is not required. This project is not considered a Project of Concern regarding particulate matter (PM10 and PM2.5) as defined in 40 CFR 93.123(b)(1).
