The subject parcels are located on the east side of Biola Avenue, between I Street and H Street, within the unincorporated community of Biola (4460 N. Biola Avenue) (Sup. Dist.: 1) (APN: 016-300-02).

Allow rezone of two contiguous parcels totaling 2.6 acres from the existing M-1 (Light Manufacturing) Zone District to an M-3 (Heavy Industrial) Zone District to allow the expansion of an existing fertilizer plant on an adjacent parcel onto the subject parcels (APN 016-300-17S & 18S).

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The subject parcel is currently undeveloped. The surrounded land includes cultivated agricultural field to the east, industrial uses to the south and west, and single-family dwellings to the north of the project site.

10. Other public agencies whose approval is required (e.g., permits, financing approval, or participation agreement.)

None.

11. Have California Native American tribes traditionally and culturally affiliated with the project area requested consultation pursuant to Public Resources Code Section 21080.3.1? NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code Section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code Section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code Section 21082.3(c) contains provisions specific to confidentiality.

The project site is not located in an area designated as highly or moderately sensitive for archeological resources. Pursuant to Assembly Bill (AB) 52, project information was routed to the Picayune Rancheria of the Chukchansi Indians, Dumna Wo Wah Tribal Government, Table Mountain Rancheria and Santa Rosa Rancheria Tachi Yokut Tribe offering them an opportunity to consult under Public Resources Code (PRC) Section 21080.3(b) with a 30-day window to formally respond to the County letter. No tribe requested consultation, resulting in no further action on the part of the County.
