<u>Project Description</u>	

A Maintenance project to inspect, clean and rehabilitate the aging concrete and metal pipes at the I-5/SR-1 separation in San Juan Capistrano and the Jamboree Road off-ramp on I-405 in Irvine. Work activities include:

On I-5 at Post Mile 6.9, upgrade existing culverts by video inspecting, cleaning, performing invert paving, repairing spalled surface areas and installing internal mechanical joint seal on the existing 8' (96") arch concrete culvert (RCPA). Work will also include video inspection, cleaning and installing a cure-in-place pipe (CIPP) liner on 60" and 84" metal (CMP) pipes.

On I-405 at PM 6.8, replace the 24" metal (CMP) pipe with a same size reinforced concrete pipe (RCP).

All work will take place within the State right-of-way. The total disturbed soil area is anticipated to be less than 1 acre. The project is funded by State sources only.
