

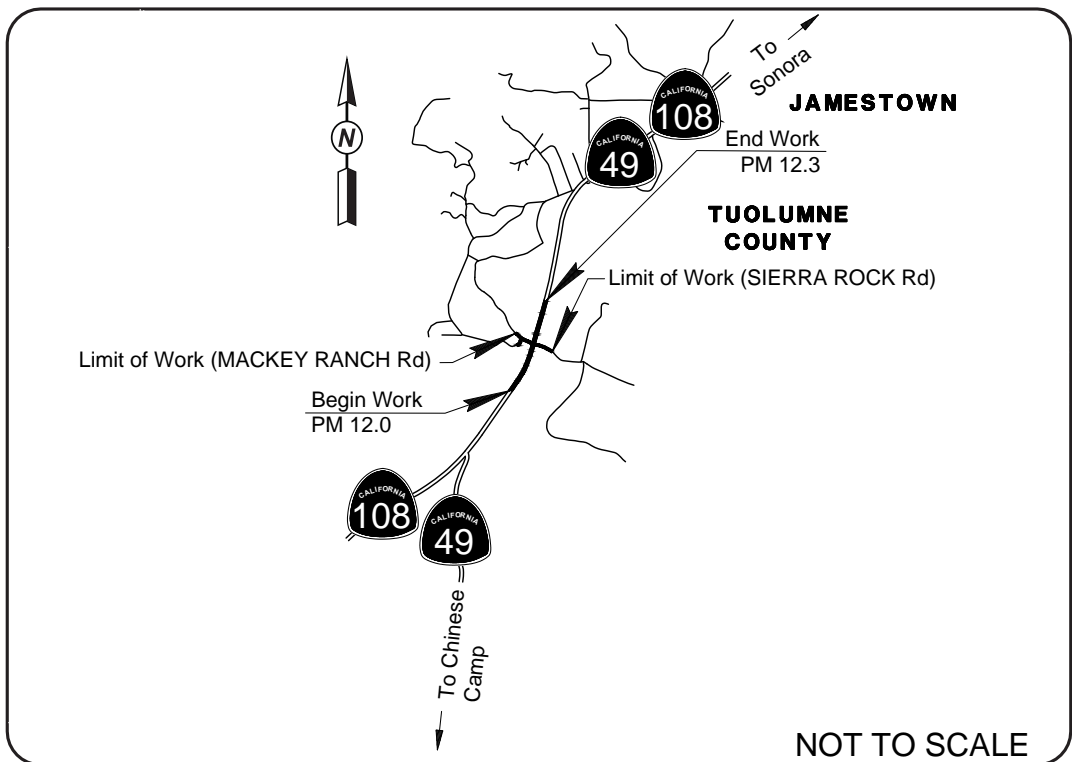

Notice of Intent to Adopt a Negative Declaration and Opportunity for a Public Hearing (Study Results Available)

Do you want a public meeting for the changes proposed to State Route 108/49 and Mackey Ranch Road Intersection Improvements Project in Tuolumne County?



PUBLIC COMMENT PERIOD

Comments will be accepted from 6HSWPEHU, 2020 to September , 2020. If there are no major comments or requests for a public hearing, Caltrans will proceed with the project's design.

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to improve overall operations, circulation, and accessibility for a variety of transportation modes by replacing the current State Route 108/49 and Mackey Ranch Road intersection in Tuolumne County with a modern yield-controlled, four-legged, single-lane roundabout with share-the-road demarcations. This project is sponsored and managed by the Chicken Ranch Rancheria of Me-Wuk Indians of California.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. This notice is to inform the public that an Initial Study with Proposed Negative Declaration has been prepared for the project and is available for review and comments.
