The proposed Palmdale Transit Area Specific Plan (PTASP) will serve as a framework and development strategy for a pedestrian-oriented mixed-use district surrounding the City of Palmdale's Transportation Center and the future high-speed rail station. The PTASP intends to coordinate land uses, development intensity, building scale, and aesthetic characteristics of future development to create a mixed-use neighborhood with amenities for existing and future residents, employees, and visitors and that supports and sustains existing and planned transit services in the planning area.
