The Project would replace the existing two-lane, single-span Kilburn bridge with a new two-lane, three-span bridge on the same general alignment as the existing bridge. The Project would provide a replacement bridge with safer standard shoulder widths and lane widths, the structural integrity to carry modern day truckloads, and a clearance over 50-year water surface elevation. The design and construction of the approach roadway and replacement bridge would be in compliance with County and Caltrans design standards, as well as AASHTO guidelines.
