Project Location: Bridge No. 22C-0091 over Cache Creek is located on County Road (CR) 40, in the remote northwestern portion of the County, which is accessed off State Route 16 approximately 5 miles northwest of the unincorporated community of Rumsey (APN 018-270-016).

Project Description: The structurally deficient Bridge No. 22C-0091 crossing over Cache Creek on CR 40 is proposed to be replaced with a new three-span, cast-in-place, reinforced concrete slab superstructure. The replacement bridge will be constructed on an improved alignment at essentially the same location as the existing bridge. The bridge replacement is needed to provide CalFire and other emergency responders access across the creek during wildfires or other emergency events. The proposed bridge is also needed to provide County personnel vehicular access to County lands. The proposed bridge design will provide a minimum freeboard clearance for recreational rafters during the summer irrigation flows.

An Initial Study/Mitigated Negative Declaration (SCH #2020099010) was prepared for the proposed Bridge Replacement Project. This is to advise that the Yolo County Board of Supervisors has adopted the Mitigated Negative Declaration for the above-described project on November 17, 2020, and has made the following determinations:
