The project plans to add cold plane 0.2' asphalt concrete pavement and replace the asphalt concrete surfacing with 0.2' hot mix asphalt. The purpose of the project is to preserve the existing facility and prevent further deterioration of the roadway. The need of the project is to address the deteriorated pavement condition. This maintenance project is warranted to increase the remaining service life of the existing pavement.
