DESCRIPTION OF PROJECT: The project proposes to install sidewalk, curb, and gutter in areas that are missing at the below locations in the Arden-Arcade and Carmichael communities of unincorporated Sacramento County. Where necessary, streetlights and drainage improvements will also be constructed along the length of the project limits.

- El Camino Avenue on the north side fronting Cardinal Oaks Park (A small retaining wall will be installed on the west portion of the sidewalk.)

- Marconi Avenue from 300 feet east of Eastern Avenue to Greenwood Avenue
- Marconi Avenue from Mission Avenue to Root Avenue
