Project Title: Streambed Alteration Agreement No. 1600-2020-0203-R2 ("Mountain House" Timber Harvest Plan (THP) 2-20-00048-SIE), Sierra Pacific Industries.

Project Location: The projects are located within the Rock Creek, Luck Dog Creek, St. Catherine Creek, Goodyears Creek, and Kanaka Creek watersheds in Sierra County, State of California. The projects are located on the Goodyears Bar, Pike, and Downieville U.S. Geological Survey (USGS) Quad Maps, Township 19N, Range 10E, Sections 7, 9 and 31 Mount Diablo Base and Meridian.

Project Description: The projects are limited to the installation of one culvert, replacement of two undersized culverts, installation of a three vented rock fords, and the construction of three rock fords. Further explanation of this work can be referenced in THP 2-20-00048-SIE.
