Replacement of existing, overgrown landscaping associated with a single-family dwelling, replacement of existing permeable driveway and walkways with permeable surfaces, replacement landscaping walls of approximately 4 feet maximum height and two (2) spas. New replacement landscaping is water conserving and includes new irrigation. Construction of a new detached garage of approximately 799 square feet, conversion of the existing detached garage and guesthouse to a gym/art studio/guesthouse with additions of 350 square feet to this structure, resulting in a detached accessory structure of approximately 1,810 square feet.
