The Department of Toxic Substances Control (DTSC) wishes to formally withdraw the Notice of Determination (NOD) filed by DTSC for the Long Beach Industrial Park (also known as “Former Oil Operators”) Response Plan (SCH No. 2020100290). The NOD was dated September 23, 2021, and posted by the State Clearinghouse (SCH) on September 28, 2021. The NOD was set aside by a Superior Court of California, County of Los Angeles Order Granting Petition for Writ of Mandate dated October 19, 2022 (Case No. 21STCP01537).
