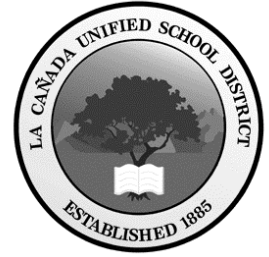

LA CAÑADA UNIFIED SCHOOL DISTRICT 30-DAY NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE IS HEREBY GIVEN that La Cañada Unified School District intends to adopt a Mitigated Negative Declaration (MND) for the following described project in accordance with the California Environmental Quality Act (CEQA) Guidelines.

PROJECT TITLE: New Outdoor Pool Facility and South of Campus Improvement Project
LEAD AGENCY: La Cañada Unified School District
PROJECT LOCATION: La Cañada High School, 4463 Oak Grove Drive, La Cañada Flintridge, Los Angeles County, Assessor's Parcel Number 5823-001-901.

PROJECT DESCRIPTION: La Cañada Unified School District is proposing improvements to the La Cañada High School campus, which would involve the demolition of the existing basketball courts to construct a 40-meter pool with a 1,176-square-foot pool equipment area, 1,620-square-foot outdoor pool storage area, 218-square-foot girls restroom, 218-square-foot boys restroom, two 378-square-foot locker rooms, a 284-square-foot indoor concrete storage area, a 411-square-foot office, and 19 outdoor showers. The existing on-campus baseball field would be shifted west to expand the student parking lot, and the existing 25-meter pool and 750-square-foot pool equipment building would be replaced with new basketball courts with associated steps/seating.

PROJECT IMPACTS: The Draft Initial Study found that the environmental effects from the project would be less than significant with implementation of required mitigation measures and compliance with existing Codes and Regulations.

PUBLIC REVIEW PERIOD: Begins: October 15, 2020

Ends: November 16, 2020

PUBLIC HEARING: A virtual public hearing will be held before the La Cañada Unified School District on **December 15, at 7:00 PM** and can be accessed via its website or this link <https://www.youtube.com/lcusdmedia>.

The Draft Initial Study/MND is being circulated for public review and comment for a period of 30 days. Any person may submit written comments to La Cañada Unified School District before the end of the review period.
