**PROJECT LOCATION:** The Project is located in the Coachella Valley of central Riverside County, in the cities of Palm Desert, Rancho Mirage, Indian Wells, and La Quinta, as well as the community of Thousand Palms in unincorporated Riverside County.

**PROJECT DESCRIPTION:** The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Clean Water State Revolving Fund (SRF) Program is financing the Project. The Project includes the installation of approximately 44,745 linear feet of new pipeline, nine new motor-actuated valves, and nine new Coachella Valley Water District water meters.

**PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:** The State Water Board has approved SRF financing for the Project described above on April 12, 2022. The Coachella Valley Water District will be carrying out the Project. The State Water Board has made the following California Environmental Quality Act (CEQA) determinations regarding the Project:

1. The Project will not have a significant effect on the environment. The Project will not have a significant effect on water quality impacts. This determination is limited to effects on water quality under the State Water Board's jurisdiction as a Responsible Agency.
2. A Mitigated Negative Declaration was prepared and adopted/certified for the Project pursuant to the provisions of CEQA.
3. Mitigation measures were made a condition of approval of the Project.
4. A mitigation monitoring and reporting plan/program was adopted for the Project.
