



NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

Based on an Initial Study, the staff of the City of Sunnyvale Department of Public Works determined that the project described below, with incorporated mitigation measures, would not have significant adverse impacts on the environment. A Mitigated Negative Declaration (MND) has been prepared for the project.

PROJECT TITLE: Rehabilitation of Storm Drain Outfall at Remington Court Project (UY-17-01)

PROJECT DESCRIPTION AND LOCATION: The City of Sunnyvale Public Works Department (City) is proposing to repair a failing storm drain outfall pipe that discharges to Stevens Creek at the end of West Remington Drive, in Sunnyvale, California. The City has determined that a 60-inch storm drain outfall that discharges directly into Stevens Creek has deteriorated and a small portion at the end of the pipe has fallen into the outfall channel connected to the creek. Engineering reports concluded that the deterioration of pipe and the lack of proper erosion control measures at the discharge point and further downstream of the low-flow channel were the key reasons for the failure of the storm drain outfall pipe and the deepening of the outfall channel. The City is proposing a project to replace the failed segment of pipeline and alter the drainage outlet to prevent future erosion at the discharge point and to prevent backups from the creek into the municipal storm drainage system.

The City of Sunnyvale is the Lead Agency for the project and the California Department of Fish and Wildlife, San Francisco Bay Regional Water Quality Control Board, Santa Clara Valley Water District, and the United States Army Corps of Engineers are responsible agencies.

WHERE TO VIEW THIS DOCUMENT: Due to the shelter in place order for Santa Clara County related to the COVID-19 pandemic, the Sunnyvale City Hall, Library and Community Center are closed to in-person services. The Mitigated Negative Declaration, its supporting documentation, and details relating to the project are available for review on the City's web site. PUBLIC COMMENT INVITED: Notice is hereby given that a Mitigated Negative Declaration has been prepared for the Rehabilitation of Storm Drain Outfall at Remington Court Project (UY-17-01) pursuant to the guidelines and procedures of the California Environmental Quality Act. The required 30-day public review period shall begin on **Friday, October 23** and end at **5:00 p.m. on Monday, November 23, 2020**. All comments regarding the MND must be received by this ending date/time.
